### Citizens' income:

A right beyond the colours!



The citizen's income is an active policy that aims at the labour integration and the promotion of social inclusion. It is an economic support in addition to the family incomes, which lasts 18 months.

It is composed of:

- an **economic benefit** as an integration income, that is provided through the citizens' income Card (RdC Card).
- the **employment pact** or **social inclusion pact** that is aimed at overcoming the state of poverty and it is also a mandatory condition in order to maintain the requirement.

Can a foreign national apply for the citizens' income?

### **Step 1: The Request**

The foreign nationals that have the requirements can apply for the citizens' income.

#### **Residence or legal requirements:**

- you must have been resident in Italy for at least 10 years of which the last two years continuously;
- you must have the Italian citizenship or the EU citizenship or a family member (spouse, dependent children - minor or adult - in case they can not provide for their own basic needs permanently, dependent relatives that do not have appropriate family support in their own country) must own the basic residence permit or the permanent one;
- you must be a third-country national that has the long-term EU residence permit (it can be released to a foreign citizen who has a valid residence permit for 5 years on condition and who shows the availability of a minimum income not less than the annual social allowance) or stateless (a person who has emigrated abroad without citizenship) that has the long-term EU residence permit;
- you must be a beneficiary of international protection (subsidiary protection, refugee status);
- you must be an homeless person that provides proof of residence in Italy for 10 years of which the last two years continuously by specifying the municipality of residence or domicile.

In addition to the requirements aforementioned, it must be considered the income and the capital requirements of the applicant's whole family. These requirements must be verified by CAF and Patronati.



### **Step 2: Submit an application for Citizens' income**

- through the website [www.redditicittadinanza.gov.it](http://www.redditicittadinanza.gov.it);
- at the post office, CAF and Patronati.

At Post Italiane office, the beneficiary of citizens' income receives a Card with the corresponding Pin code in which the money will be transferred monthly.



### **Step 3: Obligations**

You will be called from the employment office to subscribe the Employment Pact within 30 days from the provision of benefits, only if:

- an household member is out of the labour market by no more than 2 years;
- you are beneficiary of Naspi for involuntary unemployment;
- you have finished Naspi for no more than one year.

People in particular socio-economic circumstances (who have not finished school or have not specific skills or that have been out of the labour market for a long time) can be summoned by the municipalities for the submission of the Social Inclusion Pact.

The Collective Benefits Projects (known as PUC) are planned as part of Social Inclusion Pacts. These projects are elaborated by the municipality of residence depending on the person's attitudes and local requirements.

The Collective Benefits Projects consist of a group of activities on:

- the educational, cultural, social, artistic and environmental field;
- the protection of common goods;
- the public interest activities for solidarity, civil and social benefit purposes.

### **PLEASE NOTE**

During the convocation at the municipal offices, all the citizens' income earners will need to show:

- A declaration of the immediate availability to work (known as DID);
- Household official certificate;
- If necessary, any updated medical documentation that can demonstrate the inability to work.
